NOTICE OF FEE CHANGES

Effective October 25, 2010

As a result of the enactment of Senate Bill 857, various civil filing fees and criminal fees have been established or increased as of October 25, 2010. All new and increased fees sunset on July 1, 2013, except as noted below. The additional revenue from these fee changes will be used to offset reductions to trial court funding.

Fee increases are as follows:

- \$395 – Unlimited Civil Filing (GC 70611)

- \$370 – Appeal in a limited Civil case where amount demanded $> \$10,000.00$ (GC 70621(a)(1))
- \$370 – Writ petition in a limited civil case where amount demanded $> \$10,000.00$ (GC 70621(a)(2))
- \$225 – Appeal in a limited civil case where amount demanded $\leq \$10,000.00$ (GC 70621(b))
- \$225 – Writ petition in a limited civil case where amount demanded $\leq \$10,000.00$ (GC70621(b))

- \$395 – First petition for letters of administration or letters testamentary, or the first petition for special letters of administration with the powers of a general personal representative (GC 70650(a))
